

HQ Incentive Program

Official Rules & Conditions

Program Purpose

The HQ Incentive Program, sponsored by Hockenson Quarter Horses, was established to reward the success of HQ-bred horses and horses sired by HQ stallions. The program recognizes excellence in competition while rewarding the owners who choose HQ breeding programs.

All incentive earnings are paid in addition to any prize money awarded by the hosting organization.

All incentive payouts are reported to QData, ensuring each eligible horse receives permanent recognition of its HQ Incentive earnings.

Participation in the HQ Incentive Program constitutes acceptance of these Official Rules and Conditions.

Eligibility

Automatically eligible if bred by Hockenson Quarter Horses or sired by CT Show Me Your Guns, HQ Helluva Cat, HQ Top Gun, or CD Dyna Cee while under the ownership of Hockenson Quarter Horses

No Nomination Required

No nomination fees, enrollment fees, annual renewal fees, or paperwork are required.

Lifetime Eligibility

Once eligible, a horse remains eligible for life.

Eligible Events

IQHA Ranch Horse Futurity

Top three HQ money earners in each age division: 1st \$1,000, 2nd \$700, 3rd \$300.

NRCHA Snaffle Bit Futurity

Any eligible HQ horse qualifying for the Finals in any Open or Non-Pro division receives \$2,500.

Only one payout per horse. For example, if the same horse qualifies for the open and intermediate division, then the horse would only receive one payout in the amount of \$2500.

Riata Buckle Championship

Highest HQ money earner in any Riata Buckle Championship division receives \$2,500. Side pots are not eligible for earnings.

South Dakota Stallion Stakes NRCHA

Highest-scoring eligible HQ horse: Open Futurity \$1,000; Non-Pro Futurity \$1,000

Highest-scoring eligible HQ horse: Open Derby \$1,000; Non-Pro Derby \$1,000

Multiple Event Earnings

Eligible horses may earn HQ Incentive payouts at multiple events during the same calendar year with no maximum annual payout.

Ownership

Payments are made to the registered owner of record at the time of competition.

Payment

Payments issued within 30 days of official results after eligibility verification and receipt of a completed W-9.

QData Reporting

All HQ Incentive payouts will be reported to QData and included on the horse's permanent performance record.

Official Results

Official event results determine eligibility and payouts. Amended results will govern.

Ties

Tied payouts are divided equally unless the host organization breaks the tie.

Taxes

Recipients are responsible for applicable taxes.

Verification

HQ may verify registration, ownership, breeder information, stallion eligibility, and official results.

Program Changes

HQ reserves the right to modify rules, payouts, eligible events, and interpretations prospectively.

Final Authority

Hockenson Quarter Horses has final authority regarding eligibility, interpretation, and dispute resolution.
